o Whom It May Concern -

It has come to my attention that the San Juan County Democratic Party has violated provisions of RCW 42.17A.

## 1) Failure to timely file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Unfortunately, the San Juan County Democratic Party failed on numerous occasions to do this.

Unfortunately, these expenditures were not reported until 7/30/2016, roughly 4 days late.

## 2) Failure to accurately, timely report debt. (Violation of RCW 42.17A.240 (8), see WAC 390-05-295)

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days. Per WAC 390-05-295, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

The San Juan County Democratic Party failed to illegally report the following debts on preceding C4s (see "San Juan Democrats Illegal secret debt" attachment.)

### 3) Failure to properly break down expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with WAC 390-16-037, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

The San Juan County Democratic Party illegally failed to break down the following expenses. (See file titled "San Juan Democrats Illegal hidden expenditure list" attached.)

#### 4) Failure to report expenditure/in-kind contribution for mailing list. (Violation of RCW 42.17A.235)

The San Juan County Democratic Party sent out multiple mailers to registered voters within San Juan County.

The San Juan County Democratic Party used mailing lists to target specific voters in an effort to win the maximum number of voters per dollar spent.

Mailing lists have real market value, and many committees pay hundreds of dollars for mailing lists from vendors such as L2.

Unfortunately, because the San Juan County Democratic Party failed to report the expenditure for said mailing lists, or the in-kind contribution of mailing lists from some outside entity, it is in violation of **RCW 42.17A.235**. The San Juan County Democratic Party must amend its campaign finance reports to include the source of his mailing lists, either as an in-kind contribution to his campaign or as an expenditure.

### 5) Failure to list committee officers. (Violation of RCW 42.17A.205 (2)(c), see WAC 390-05-245.

The San Juan County Democratic Party failed to list the following officers, which is required by **RCW 42.17A.205(2)(c)**. The following officers were elected on or about December 12<sup>th</sup>, 2016(during the "reorg" meeting) with terms that began immediately:

Unfortunately, the San Juan County Democratic Party failed to include most of the officers (with the sole exception of Chair Turnoy) on their amended C1PC. They were required to list these officers on their C1PC form within 10 days of their taking office.

Please note that **RCW 42.17A.005 (35)** defines "person" as: "...an individual, partnership, joint venture, public or private corporation, association, federal, state, or local governmental entity or agency however constituted, candidate, committee, political committee, political party, executive committee thereof, or any other organization or group of persons, however organized."

# 6) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C-1 form. (Violation of RCW 42.17A.425)

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

In their roles on the San Juan County Democratic Party's board, these individuals doubtlessly made illegal expenditures for the committee, in violation of state law.

The PDC should investigate the possibility that The San Juan County Democratic Party committed the above violations maliciously, which would be a class C felony per RCW 42.17A.750 (2)(c). If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
