STIPULATION

The parties to this stipulation, Plaintiff, STATE OF WASHINGTON (STATE), and the Defendant, SAN JUAN COUNTY DEMOCRATS, a Washington registered political committee, desiring to resolve all claims arising out of the State's complaint, hereby enter into the following stipulation:

- Defendant SAN JUAN COUNTY DEMOCRATS agrees to pay the State an assessed civil
 penalty in the amount of \$8,220 for its violations of RCW 42.17A for failing to report
 contributions received, expenditures made and debts and obligations incurred in 2016.
- 2. The parties agree that \$4,110 of the assessed civil penalty will be suspended based on the following terms and conditions:
 - a. The suspension will be in effect for four years from the date of execution of the Judgment. During the period of suspension, Defendant, SAN JUAN COUNTY DEMOCRATS agrees that it will not violate any provision of RCW 42.17A.
 - b. In the event Defendant SAN JUAN COUNTY DEMOCRATS is found by the Public Disclosure Commission or a court to have committed a violation of RCW 42.17A during the suspension period, the suspended penalty of \$4,110 will immediately become due and payable within 30 days of such finding without further intervention of the Court.
 - c. If Defendant SAN JUAN COUNTY DEMOCRATS is not found to have committed violations of RCW 42.17A by the Public Disclosure Commission or a court for conduct occurring during the suspension period, then the suspended portion of the penalty will be set aside.

3. Defendant SAN JUAN COUNTY DEMOCRATS agrees to pay the State the total amour		
of \$4,885 as reasonable attorney fees (\$4,000), court costs (\$240), and costs of investigation		
(\$645) in this action.		
4. Defendant SAN JUAN COUNTY DEMOCRATS agrees to pay the State the unsuspended		
portion of the civil penalty (\$4,110) and fees and costs (\$4,885) within 30 days from the date		
of the entry of the Judgment.

THIS MATTER came on regularly before the undersigned judge of the above-entitled Court. Plaintiff, STATE OF WASHINGTON (STATE), appearing through its attorneys of record, LINDA A. DALTON, Senior Assistant Attorney General, and KELLY R. HARMON, Assistant Attorney General, and Defendant, SAN JUAN COUNTY DEMOCRATS, a Washington registered political committee, appearing through its attorney, LAURA EWAN, apprised the Court of their agreement to the entry of this judgment for the purpose of settling and compromising this action brought under RCW 42.17A. The Court, having reviewed the records and files herein, and having found the settlement to be a just and proper resolution of this matter, and being otherwise fully advised in the premises, it is hereby ORDERED as follows:

- Defendant SAN JUAN COUNTY DEMOCRATS is hereby assessed a civil penalty, under the provisions of RCW 42.17A, in the amount of \$8,220 payable to the State of Washington.
- 2. The amount of \$4,110 of the assessed penalty is hereby suspended upon Defendant SAN JUAN COUNTY DEMOCRATS' compliance with the following court-ordered conditions:
 - a. The suspension shall be in effect for four years from the date of execution of the Judgment. During the period of suspension, Defendant SAN JUAN COUNTY DEMOCRATS agrees that it will not violate any provision of RCW 42.17A.
 - b. In the event Defendant SAN JUAN COUNTY DEMOCRATS is found by the Public Disclosure Commission or a court to have committed a violation of RCW 42.17A during the suspension period, the suspended penalty of \$4,110 shall be immediately due and payable within 30 days of such finding without further intervention of the Court.
 - c. If Defendant SAN JUAN COUNTY DEMOCRATS is not found to have committed violations of RCW 42.17A by the Public Disclosure Commission or a court for conduct

1	occurring during the suspension period, then the suspended portion of the penalty shall
2	be set aside.
3	3. Defendant SAN JUAN COUNTY DEMOCRATS shall pay the State the total amount of
4	\$4,885 as reasonable attorney fees (\$4,000), court costs (\$240), and costs of investigation
5	(\$645) in this action.
6	4. Defendant SAN JUAN COUNTY DEMOCRATS shall pay the State the unsuspended
7	portion of the civil penalty (\$4,110) and fees and costs (\$4,885) within 30 days from the
8	date of the entry of the Judgment.
