To Whom it May Concern --

It has come to my attention that the PAC "South King County Democrats" have committed multiple violations of **RCW 42.17A** over a period of the last 3 years.

### 1) Failure to file accurate, timely C3 and C4 reports. (Violation of RCW 42.17A.235)

State law requires that candidates and committees file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt.

Unfortunately, South King County Democrats have failed on numerous occasions to do this. (See Exhibits A and B.). Please note that many of these contribution and expenditure reports are well over 200 and even 600 days late. This is particularly egregious and substantially out of compliance. Please also note that **at least \$12,209 of contributions were reported egregiously late**, and **over \$7,100 in expenditures** were also reported extremely late.

I have good reason to believe there are other contributions and expenditures that have been made by the Committee that have still not been reported.

For example, I can see from campaign records that IBEW 77 PAC made a contribution of \$1000 on 11/9/2016 that has still not been reported. It is likely this is just the tip of the iceberg for the campaign finance violations by the South King County Democrats PAC.

Please note, it is likely that the only way the PDC will be able to unravel the truth about what donations or expenditures were actually made from this PAC would be to subpoen the bank statements and verify the check registry as well (Please note, allegation #4 below would also need to be clarified based on check signatory and which officers had and do have signing authority at the bank during this timeframe).

### 2) Failure to accurately, timely report debt. (Violation of RCW 42.17A.240 (8), see WAC 390-05-295)

State law requires that the name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days. Per **WAC 390-05-295**, this includes any oral or written order placed, debt or obligation to purchase goods or services or anything of value, or any offer to purchase advertising space, broadcast time or other advertising related product or service.

South King Democrats illegally failed to report the following debts: (See Exhibit C.)

#### 3) Failure to properly break down expenses. (Violation of RCW 42.17A.235, see WAC 390-16-205)

State law requires that expenditures made on behalf of a candidate or political committee by any person, agency, firm, organization, etc. employed or retained for the purpose of organizing, directing, managing or assisting the candidate's or committee's efforts shall be deemed expenditures by the candidate or committee. In accordance with **WAC 390-16-037**, such expenditures shall be reported by the candidate or committee as if made or incurred by the candidate or committee directly.

South King Democrats illegally failed to break down the following expenses. (See Exhibit D.)

### 4) Failure to list all committee officers. (Violation of RCW 42.17A.205 (2)(c), see WAC 390-05-245.

The South King Democrats failed to list the chairs of the 33rd, 34th, and 47th District Democrats as officers, which is required by **RCW 42.17A.205(2)(c)**.

The South King Democrats hosts fundraisers that splits event proceeds between four separate Democratic Legislative Districts – 30th, 33rd, 34th, and 47th. All decisions related to the Committee's activity are made by the respective chairs of these four districts.

Tim Burns (30th LD Chair) is the only one currently listed as an officer on the C1PC form.

The above individuals should have been listed as committee officers, because they, in conjunction with others, made, directed, or authorized expenditures, strategic or policy decisions on behalf of the committee.

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee".

Please note that **RCW 42.17A.005 (35)** defines "person" as: "...an individual, partnership, joint venture, public or private corporation, association, federal, state, or local governmental entity or agency however constituted, candidate, committee, political party, executive committee thereof, or any other organization or group of persons, however organized."

## 5) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C-1PC form. (Violation of RCW 42.17A.425)

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

Despite making all the decisions for the Committee, only one of the four officers are listed on the C1PC. In their roles as officers, these individual doubtlessly made illegal expenditures on behalf of the committee.

The PDC should investigate the possibility that the South King County Democrats committed the above violations maliciously (in particular, the contributions still not reported), which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
