

To whom it may concern,

It has come to my attention that a wide variety and quantity of violations of **RCW 42.17A** may have been committed by Tina Podlodowski during her failed 2016 campaign for the Washington State Secretary of State office. The details of these violations are as follows:

**(1) Failure to timely file C3 and C4 reports on the day the treasurer is designated. RCW 42.17A.235(1) states that “on the day the treasurer is designated, each candidate or political committee must file with the commission a report of all contributions received and expenditures made prior to that date, if any.”**

Ms. Podlodowski filed her [C1 Report](#), which designated Abbot Taylor as her treasurer, on 1/5/16. Ms. Podlodowski violated [RCW 42.17A.235\(1\)](#) by failing to timely report three contributions/expenditures made prior to that date.

- Cash contribution of \$500 made by Tina Podlodowski on 1/4/16. Rather than reporting the contribution by 1/5/16, Ms. Podlodowski reported it one month late on 2/5/16 (see Report No. 100677198).
- In-kind contribution of \$33.86 made by Tina Podlodowski on 1/4/16 for “Bartell Drugs – campaign phone.” Rather than reporting the contribution by 1/5/16, Ms. Podlodowski reported it over one month late on 2/8/16 (see Report No. 100677509).
- An expenditure of \$22.50 made on 1/1/16. Rather than reporting the expenditure on 1/5/16, Ms. Podlodowski reported it over one month late on 2/8/16 (see Report No. 100677509).

**(2) Failure to timely file accurate C3 and C4 reports. RCW 42.17A.235 requires candidates and committees to file frequent, accurate reports of contributions, expenditures, in-kind contributions, and debt. Ms. Podlodowski violated this statute as follows:**

- Ms. Podlodowski made an expenditure of \$118.34 to Katherine Bobman on 1/26/16 for "Metropolitan Market - food for event." Ms. Podlodowski should have reported this expenditure no later than 2/10/16 (see Report No. [100677509](#)). Instead, Ms. Podlodowski reported this expenditure late on 2/15/16 (see Report No. [100678869](#)).
- Ms. Podlodowski made an expenditure of \$71.78 to Raven McShane Strategies on 1/26/16 for "Esquin - wine for event." Ms. Podlodowski should have reported this expenditure no later than 2/10/16 (see Report No. [100677509](#)). Instead, Ms. Podlodowski reported this expenditure late on 2/15/16 (see Report No. [100678869](#)).
- Ms. Podlodowski made an in-kind contribution of \$633.20 on 1/28/16 for "Alaska Airlines - travel." Ms. Podlodowski should have reported this expenditure no later than 2/10/16 (see Report No. [100677509](#)). Instead, Ms. Podlodowski reported this expenditure late on 2/23/16, this was **13 days past the statutory deadline** (see Report No. [100679388](#)).
- Ms. Podlodowski made an in-kind contribution of \$500 on 2/2/16 for "Emily's List - ad in event program." Ms. Podlodowski should have reported this contribution no later than 3/10/16 (see Report No. [100685470](#)). Instead, Ms. Podlodowski reported this contribution late on 3/18/16, **eight days past the statutory deadline** (see Report No. [100687088](#)).
- Ms. Podlodowski made an in-kind contribution of \$25 on 5/31/16 for “City Club – ticket for event.” Ms. Podlodowski should have reported this contribution no later than 6/10/16 (see Report No. [100700470](#)). Instead, Ms. Podlodowski reported this expenditure late on 6/14/16 (see Report No. [100702315](#)).
  - In Report No. [100707905](#), Ms. Podlodowski reported that she made an in-kind contribution worth \$65.74 on 7/11/16 for “Zeeks – pizza for volunteers.” The amount was reported incorrectly. Ms. Podlodowski should have reported the correct contribution no later than 7/12/16. Instead, Ms. Podlodowski reported the correct contribution (\$70.74) on 7/18/16, **six days past the statutory deadline** (see Report No. [100708969](#)).
- Ms. Podlodowski paid \$817.80 to NARAL Pro-Choice Washington on 7/21/16 for "membership list." Ms. Podlodowski should have reported this expenditure no later than 7/26/16 (see Report

No. [100711520](#)). Instead, Ms. Podlodowski reported this expenditure late on 7/27/16 (see Report No. [100711877](#)).

- Ms. Podlodowski received an in-kind contribution of \$500 from Kelly Evans on 10/18/16 for "refreshments & parking services for event (Trader." Ms. Podlodowski should have reported this contribution no later than 11/1/16 (see Report No. [100732869](#)). Instead, Ms. Podlodowski reported this expenditure late on 11/2/16 (see Report No. [100733376](#)).
- Ms. Podlodowski received an in-kind contribution of \$87.70 from Asian Pacific Islander on 10/19/16 for "print ad in NW Asian Weekly." Ms. Podlodowski should have reported this contribution no later than 11/1/16 (see Report No. [100732869](#)). Instead, Ms. Podlodowski reported this expenditure late on 11/7/16, **six days past the statutory deadline** (see Report No. [100734216](#)).
- Ms. Podlodowski received an in-kind contribution of \$72.85 from Asian Pacific Islander on 10/19/16 for "print ad in Seattle Chinese Post." Ms. Podlodowski should have reported this contribution no later than 11/1/16 (see Report No. [100732869](#)). Instead, Ms. Podlodowski reported this expenditure late on 11/7/16, **again six days past the statutory deadline** (see Report No. [100734216](#)).
- Ms. Podlodowski received an in-kind contribution of \$54.85 from Asian Pacific Islander on 10/25/16 for "print ad in Int'l Examiner." Ms. Podlodowski should have reported this contribution no later than 11/1/16 (see Report No. [100732869](#)). Instead, Ms. Podlodowski reported this expenditure late on 11/7/16, also **six days past the statutory deadline** (see Report No. [100734216](#)).

**(3) Failure to timely and accurately report debt. RCW 42.17A.240(8) requires a candidate to disclose the "name and address of any person and the amount owed for any debt, obligation, note, unpaid loan, or other liability in the amount of more than two hundred fifty dollars or in the amount of more than fifty dollars that has been outstanding for over thirty days." Ms. Podlodowski violated this law as follows:**

- In Report No. [100740977](#), Ms. Podlodowski paid \$3000 to Moxie Media, Inc. on 12/12/16 for "Madeleine Foutch - bonus." Bonuses are agreed upon and stipulated in service contracts. Ms. Podlodowski should have reported this \$3000 bonus as a debt obligation at the time she signed a contract with Moxie Media, Inc. (in January 2016) for their services. **The only way to confirm the scope of Ms. Podlodowski violation of this statute is to obtain and review a copy of her contract with Moxie Media, Inc., and/or a contract with Madeleine Foutch, a copy of which should be subpoenaed during the investigation.**

**(4) Failure to describe goods and/or services in detail. Ms. Podlodowski made numerous violations of RCW 42.17A.235 and 42.17A.240(6) (which requires a candidate to disclose "the name and address of each person to whom an expenditure was made in the aggregate amount of more than fifty dollars during the period covered by this report, the amount, date, and purpose of each expenditure"), and WAC 390-16-037(3) (which requires a candidate to "describe in detail the goods and/or services to be provided by the recipient of the expenditure"). WAC 390-16-037 also provides three examples of the detail required (Examples A, B and C below).**

"Example A: If an expenditure is for a get-out-the-vote campaign, the purpose shall include the following details:

- In Report No. [100732869](#), Ms. Podlodowski made an in-kind contribution of \$144.38 on 10/31/16 for "Facebook – online ads." Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., Facebook) and the dates the ads appeared.
- In Report No. [100732869](#), Ms. Podlodowski made an in-kind contribution of \$188 on 10/31/16 for "USPS – postage." Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., United States Postal Service).

- In Report No. [100732869](#), Ms. Podlodowski made a debt obligation of \$1814.25 to Abbot Taylor on 10/31/16 for "treasury services." Ms. Podlodowski failed to disclose the time-period for which the "treasury services" were provided.
- In Report No. [100732869](#), Ms. Podlodowski made a debt obligation of \$5250 to Newman Partners on 10/31/16 for "fundraising" services. Ms. Podlodowski failed to disclose the time-period for which the "fundraising" services were provided.
- In Report No. [100732869](#), Ms. Podlodowski made a debt obligation of \$2900 to Latino Progress Alliance on 10/31/16 for "phone banking/canvassing." Ms. Podlodowski failed to disclose the time-period for which the "phone banking/canvassing" services were provided.

- In Report No. [100737512](#), Ms. Podlodowski paid \$1814.25 to Abbot Taylor on 11/2/16 for "treasury services." Ms. Podlodowski failed to disclose the time-period for which the "treasury services" were provided.
- In Report No. [100737512](#), Ms. Podlodowski paid \$2900 to Latino Progress Alliance on 11/3/16 for "phone banking/canvassing." Ms. Podlodowski failed to disclose the time-period for which the "phone banking/canvassing" services were provided.
- In Report No. [100737512](#), Ms. Podlodowski paid \$5250 to Newman Partners on 11/3/16 for "fundraising" services. Ms. Podlodowski failed to disclose the time-period for which the "fundraising" services were provided.

If that is the case, Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., Facebook) and someone really mucked it up on ORCA. Also, Ms. Podlodowski failed to disclose the dates the ads appeared.
- In Report No. [100737512](#), Ms. Podlodowski paid \$52.44 to "Tina Podlodowski" on 11/14/16 for "Starbucks – coffee for volunteers." This report is confusing. I can only assume that Ms. Podlodowski made an in-kind contribution of \$52.44 to buy coffee at Starbucks for her volunteers. If that is the case, Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., Starbucks) and someone really mucked it up on ORCA.
- In Report No. [100737512](#), Ms. Podlodowski paid \$741.04 to "Tina Podlodowski" on 11/14/16 for "The Westin – lodging." This report is confusing. I can only assume that Ms. Podlodowski made an in-kind contribution of \$741.04 to pay for lodging at The Westin. If that is the case, Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., The Westin) and someone really mucked it up on ORCA.
- In Report No. [100737512](#), Ms. Podlodowski paid \$493.74 to Madeleine Foutch on 11/14/16 for "LifeWise – health insurance." Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., LifeWise).
- In Report No. [100737512](#), Ms. Podlodowski paid \$139.56 to Madeleine Foutch on 11/14/16 for "Verizon – cell phone." Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., Verizon).
- In Report No. [100737512](#), Ms. Podlodowski paid \$1668.48 to "Tina Podlodowski" on 11/14/16 for "Terra Plata – campaign dinner." This report is confusing. I can only assume that Ms. Podlodowski made an in-kind contribution of \$1668.48 to pay for a campaign dinner at Terra Plata. If that is the case, Ms. Podlodowski failed to disclose the address of the actual vendor (i.e., Terra Plata) and someone really mucked it up on ORCA.
- In Report No. [100737512](#), Ms. Podlodowski paid \$5250 to Newman Partners on 11/30/16 for "fundraising." Ms. Podlodowski failed to disclose the time-period for which the "fundraising" services were provided.



- In Report No. [100737512](#), Ms. Podlodowski made a debt obligation of \$837.75 to Abbot Taylor on 11/30/16 for "treasury services." Ms. Podlodowski failed to disclose the time-period for which the "treasury services" were provided.

**(5) Failure to identify committee officers. RCW 42.17A.205(2)(c) requires a candidate to file a statement of organization that identifies “the names, addresses, and titles of its officers; or if it has no officers, the names, addresses, and titles of its responsible leaders.”**

Ms. Podlodowski failed to identify committee officers in her [C1 Report](#). Ms. Podlodowski paid a total of \$60,804 to Moxie Media, Inc. for "Madeleine Foutch – campaign management" and "Madeleine Foutch – bonus." These facts support the allegation that Ms. Foutch held a position of responsibility in Ms. Podlodowski campaign, one in which Ms. Foutch made leadership and/or expenditure decisions.

**To further verify and provide additional support for this this violation allegation, a copy of Ms. Podlodowski’s contract with Moxie Media, Inc. and/or Ms. Foutch would be useful evidence.**

The above individuals should have been listed as committee officers, because they, in conjunction with others, made, directed, or authorized expenditures, strategic or policy decisions on behalf of the committee.

**WAC 390-05-245** defines committee officer as: "...any person designated by the committee as an officer on the C-1 or C-1pc registration statement and any person who alone or in conjunction with other persons makes, directs, or authorizes contribution, expenditure, strategic or policy decisions on behalf of the committee" .

Please note that **RCW 42.17A.005 (35)** defines "person" as: "...an individual, partnership, joint venture, public or private corporation, association, federal, state, or local governmental entity or agency however constituted, candidate, committee, political committee, political party, executive committee thereof, or any other organization or group of persons, however organized."

**6) Illegal unauthorized expenditure of funds by an individual not listed as an officer on C-1PC form. (Violation of RCW 42.17A.425)**

State law requires that: "No expenditures may be made or incurred by any candidate or political committee unless authorized by the candidate or the person or persons named on the candidate's or committee's registration form..."

Despite making all the decisions for the Committee, only one of the four officers are listed on the C1PC. In their roles as officers, these individual doubtlessly made illegal expenditures on behalf of the committee.

The PDC should investigate the possibility that Tina Podlodowski committed the above violations maliciously, which would be a class C felony per **RCW 42.17A.750 (2)(c)**. If the PDC determines that is the case, they should refer the case to the Attorney General's office for criminal prosecution immediately.
