You are not required to provide your name. However, if you choose not to provide your name, we are unable to keep you updated on the progress of our investigation, or to consult with you regarding the details of your complaint.

As of July 28, 2013, under RCW 42.52.410

(3)(a) A state employee who files a complaint with the appropriate ethics board shall be afforded the protection afforded to a whistleblower under RCW 42.40.050 and 49.60.210(2), subject to the limitations of RCW 42.40.035 and 42.40.910. An agency, manager, or supervisor may not retaliate against a state employee who, after making a reasonable attempt to ascertain the correctness of the information furnished, files a complaint with the appropriate ethics board. (b) A state employee may not be denied the protections in chapter 42.40 RCW even if the ethics board denies an investigation of the complaint.

(4) If a determination is made that a reprisal or retaliatory action has been taken against the state employee, the retaliator may be subject to a civil penalty of up to five thousand dollars.

Further, under RCW 42.52.420(4), the identity of a person filing a complaint under RCW 42.52.410(1) is exempt from public disclosure, as provided in RCW 42.56.240.

It has come to my attention that RCW 42.52.180 is being or has been violated by Mary Robnett, an employee of the Attorney General's Office and a 2018 candidate for Pierce County Prosecutor.

1) Illegal use of public agency time to campaign. (Violation of RCW 42.52.180)

State law prohibits public employees from campaigning during work hours.

Robnett has violated this provision in many instances. This includes, but is not limited to, her use of social media to campaign during work hours.

According to reporting done by the SnoCoReporter, Robnett has used social media for campaign purposes on at least 10 separate occasions. (See attachment, including time stamps.)

For example, on February 1, 2018 (a Thursday) at 1:13 PM, Robnett posted a link to her campaign's website where people were invited to "Make a Donation" to her campaign committee. This posting was made using her personal account.

These campaign-related postings are unrelated to and incompatible with the work that taxpayers expect her to perform during work hours.

This investigation should include a review of other state resources under Robnett's control to determine whether or not they have also been illegally used to assist her campaign.
