

6 **STIPULATION**

7 The parties to this stipulation, Plaintiff, STATE OF WASHINGTON (STATE) and
8 Defendant, JUSTIN GALLOWAY, individually, and in his capacity as Treasurer of the
9 SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, desiring to resolve claims
10 arising out of the State's Complaint against Mr. Galloway, hereby enter into the following
11 stipulation:

12 1. Defendant JUSTIN GALLOWAY, individually, and in his capacity as Treasurer of the
13 SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE, agrees to pay an
14 assessed civil penalty in the amount of \$500 for his violations of RCW 42.17A as alleged in
15 the State's Complaint including failing to timely disclose contributions received and
16 expenditures made and failing to timely deposit contributions received by Defendant
17 SPOKANE COUNTY DEMOCRATIC CENTRAL COMMITTEE. Defendant JUSTIN
18 GALLOWAY, individually, and in his capacity as Treasurer of the SPOKANE COUNTY
19 DEMOCRATIC CENTRAL COMMITTEE, further agrees to pay the State the civil penalty
20 (\$500) within 30 days from the date of the entry of the Judgment.



11 fully advised in the premises, hereby ORDERS as follows:


- 12 1. Defendants JUSTIN GALLOWAY, individually, and in his capacity as Treasurer of the
