

Police Arrest Report on Kevin Ranker

Subject Arrested: Kevin M. Ranker
Arrest Date: 7-15-95

Description: Disorderly Conduct, Interfering
with a Public Event, Resisting Arrest



Excerpt from Olympia Police Officer Thuline's Arrest Report (incident 95-6735):

"The parade was delayed ... He [Ranker] was carrying a protest sign... yelling about ... freeing of prisoners. The signs said...

Who is this Mumia Abu-Jamal who Kevin Ranker thought worth getting arrested and RESISTING arrest in the middle of a family parade in Olympia? Black Panther member Mumia Abu-Jamal is a convicted COP KILLER on death row who killed Philadelphia Police Officer Daniel Faulkner. There were witnesses. Kevin Ranker chose to demand this killer's release from prison on the day he was arrested in Olympia.

Excerpt from Olympia Police Officer Hayes' Arrest Report (incident #95-6735):

RANKER REFUSED TO MOVE. I NOW TOLD RANKER HE WAS UNDER ARREST. I GRABBED RANKER BY THE ARM AND HE ATTEMPTED TO PULL AWAY. I WAS ABLE TO FORCE RANKER TO THE GROUND AND HANDCUFF HIM. RANKER STARTED TO YELL THAT I WAS HURTING HIM. I THEN ESCORTED RANKER OUT OF THE PARADE ROUTE AS HE YELLED, HE WAS BEING ARRESTED FOR FREEDOM.

RANKER AND HIS TWO FELLOW PROTESTERS WERE TRANSPORTED TO OLYMPIA POLICE DEPT. WHERE THEY WERE BOOKED FOR INTERFERING W/ARREST. RANKER ALSO HAD AN ADDITIONAL CHARGE OF RESISTING ARREST.

Note: Ranker says, "he worked for over 15 years focusing on coastal and ocean policy and community development at the local, national and international level." The Skagit Valley Herald (8-17-08) and the Bellingham Herald 8-21-08 wrote, "Kevin has 15 years professional experience in the private and public sectors, developing and advancing legislation, community development strategies..." **THE TRUTH:** During this time frame Ranker was resisting arrest in Olympia.
