### Background

The information included in this workbook is confidential. It was compiled by Risk Management to assist Health Services and DOC leadership with understanding the scope of bio-chemical and pharmaceutical experiments performed on individuals incarcerated in DOC institutions from the 1950s-1970s. The information is based on original source material that was discovered by Health Services staff in late 2019? and reflects a preliminary and incomplete review of the material. What is described here and in tab 2 "studies" is likely to have inaccuracies, partly due to the high likelihood of missing documents and also due to the very brief review conducted to support a prelim discussion.

### Description of materials

The materials include approx 500 pages of documents. WSP hospital administrative records including annual and monthly statistical reports comprise the largest segment of documents (approx 33%) followed by the Ditran experiments (27%), which contain detailed notes on acute patient responses to Ditran, an anticholinergic that was tested as part of a broad range of chemical warfare testing initiated by the U.S. military. The DuPont de Nemours influenza study documents comprise 23%. The University of Washington radiation experiments reflect 14% of the documents and appear to include payroll records reflecting payments to participants of related studies including: Syntex drug study; Win Group Study, which appears to include studies of "win", testosterone and clomid; and a Battelle-Hanford Study. There is at least one mention of a THA experiment, a possible antidote to Ditran, and a few documents related to an ethnine study sponsored by Purdue Frederick Co. to suppress unproductive coughs. Among the misc WSP records, there are documents related to consultations and autopsies, but it is unclear if they are related to individuals who participated in any of the studies.

### Description of participants

The majority of study participants were incarcerated at WSP in Walla Walla. The influenza study also included individuals at WCC in Shelton. The vast majority were men. There are only two women clearly documented as participants. At that time, WSP included a female unit. Fortunately, OMNI contains some information about the handful of participants searched by DOC number. For example, the radiation payroll records indicate that with DOC number was part of the syntex study and was paid \$10 for the month of April 1970.

OMNI returned the offender page with the following info:

- First and last name; DOB; Current age (if still living); Gender

The OMNI status page shows that his incarceration ended on 9/5/1963.

The OMNI personal characteristics page provided the following additional information:

- Middle name; FBI number; SSN; and physical characteristics

Individuals included in earlier studies were also found in OMNI. For example,
participated in the Ditran study in the early 1960s. OMNI returned a significant amount of information on this individual, perhaps because he appears to be a years old.

### Literature

There appears to be fairly substantial literature on some of the experiments such as the radiation and chemical warfare testing, but again this review was very limited. A brief search of the National Archives reveals numerous documents as do generic online searches.
