To whom it may concern,

After looking a bit closer at the North Thurston Citizens for Schools PAC, it has come to my attention that there are additional violations of Washington State's Campaign Finance laws (RCW 42.17A) worth noting for the record. The details are as follows:

1) Failure to timely report contributions or expenditures (Violation of RCW 42.17A.235, RCW 42.17A.240)

I realized after I filed my recent updated response on the ongoing investigation into the North Thurston Citizens for Schools PAC (See PDC Enforcement Case #140433). These details should be provided to the PDC staff investigator and combined with the ongoing investigation efforts to get to the bottom of exactly what the heck is going on with this PAC. Every time I glance at it again, it just keeps getting worse.

This violation, I believe is far more serious than the one I have already outlined for this PAC, other than the possible RCW 42.17A.555 violations that appear to be starting to be uncovered by this PACs recent revelations about sources of in-kind contributions.

However, I reviewed the history of late reports for this PAC, and clearly it might be more effective for this PAC to start filing their reports in a timely manner. In a distressingly, all too often repeated pattern, this committee files reports late (67 reports, to be exact). Many of these reports have been filed weeks or months late. In an effort to help PDC staff properly categorize the lateness of these reports, my attached spreadsheets provide a color-coded reference category for helpful sorting:

Red (Extremely late – harming the public's right to know) 38 extremely late reports – up to 106 days late. There really is no excuse for these extremely late reports to have concealed so much critical information from the public for so long.

Orange (Concerningly late – delaying the public's right to know) 13 concerningly late reports – up to 12 days late. Again, not legal and not following the law

Yellow (Sloppily late – delayed reporting) 16 sloppily late reports – up to 3 days late. These could just be mistakes, sloppy bookkeeping, and written off as typical fumbling around by the treasurer, however, I'm including them in this report so that PDC staff can put this general widespread pattern of lawbreaking in proper context.

Again, I've provided both an Excel file and PDF version of the same file for ease of staff and the lawbreaker's reference as they re-educate themselves with Washington State's campaign finance laws and are reminded that these laws apply to them as well. They are not exempt from them as much as they might want to pretend these laws don't matter.

Some notes on documenting these violation:

Again, as I strive to provide the best data possible both for efficiency of staff and the lawbreakers I have identified, every report can be direct linked to the URL in the far right hand column. The date the report was due is provided and the actual date it was finally sent to the PDC and the total number of days late for those reports is included for ease of PDC staff research effort, and to quantify the significance of these violations both individually and cumulatively with the obvious problems caused by not informing the public about the truth of their activities in a timely manner.

I apologize for not providing this detail of violations documented for this PAC in the original complaint I filed on this one, and this failure to be thorough and more comprehensive in my complaints will serve as a reminder to me for my future complaints to be more diligent and comprehensive when filing these types of complaints in the near future. I confess to a bit of laziness in this specific case because I mistakenly presumed that this PAC was making some attempt to follow the law, and I originally didn't cross reference all the C4s and C3s actual submission dates with their due dates. I'll try to be more careful in future complaints to provide these details.

Please let me know if you need more information on this PAC, although I feel that this and the previous addendum to this complaint for PDC Enforcement Case #140433 is adequate to properly justify an expansion of the investigation into this particular crew of lawbreakers.
